4.1. Description of Necessary Measures

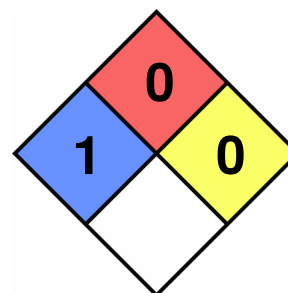
