4.3. Immediate Medical Attention or Special Treatment Needed

Irrigate immediately with large quantity of water for at least 15 minutes. Call a physician if irritation develops. Not expected to require first aid measures. 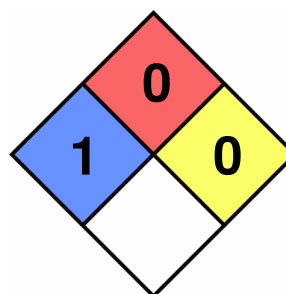
