4.1. Description of Necessary Measures

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. May cause irritation, redness, pain, and tearing.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage DANGER! Corrosive. Oxidizer. May be fatal if swallowed. Do not get in eyes, on skin, or on clothing. Avoid breathing vapor. Use with adequate ventilation. If swallowed, do not induce vomiting. Give large quantity of water. Call a physician. Wash areas of contact with plenty of water for 15 minutes. For eyes, get medical attention. EYE CONTACT: May cause irritation, redness, pain, and tearing. SKIN CONTACT: May cause irritation, redness, and pain. CHRONIC EFFECTS / CARCINOGENICITY: Repeated exposure may cause skin rash and possible sensitization.

4.3. Immediate Medical Attention or Special Treatment Needed

Immediately call a poison center or doctor. Irrigate immediately with large quantity of water for at least 15 minutes. Call a physician if irritation develops. Remove to fresh air. 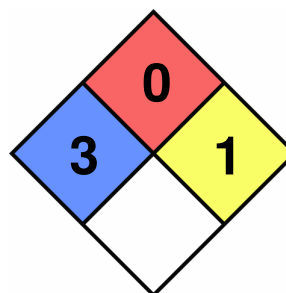
