SECTION 4: First-Aid Measures

4.1. Description of Necessary Measures

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. May cause irritation, redness, pain, tearing and burns. Symptoms may include corneal ulceration and possible damage to vision.

Ingestion: IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Dilute with large amounts of water. Do not induce vomiting. Vomiting may cause further damage due to the corrosive nature of this product. Call a physician.

Inhalation: IF INHALED: Remove person to fresh air and keep comfortable for breathing.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage CAUTION! Oxidizer. Reacts with a broad range of materials. Corrosive. Respiratory irritant. Causes burns to eyes and skin. Wash areas of contact with plenty of water. For eyes, get medical attention. If ingested, give large quantity of water. Call a physician. EYE CONTACT: May cause irritation, redness, pain, tearing and burns. Symptoms may include corneal ulceration and possible damage to vision. SKIN CONTACT: May cause irritation, redness and pain. Corrosive destruction is possible. Exposure may bleach skin white.

4.3. Immediate Medical Attention or Special Treatment Needed

Immediately call a poison center or doctor. Irrigate immediately with large quantity of water for at least 15 minutes. Call a physician if irritation develops. Remove to fresh air. Give artificial respiration if necessary. If breathing is difficult, give oxygen. Observe 48 hours for lung effects. Wash areas of contact with soap and water for at least 15 minutes. Call a physician if irritation develops. Dilute with large amounts of water. Do not induce vomiting. Vomiting may cause further damage due to the corrosive nature of this product. Call a physician.

6.1. Personal Precautions, Protective Equipment and Emergency Procedures

Wear protective gloves and eye protection.

6.2. Cleanup and Containment Methods and Materials

Cover spill with a 1:1:1 mixture of Sodium Carbonate, clay cat litter and sand. Scoop up, then transfer to hood. Slowly add to a pail of cold water. Gradually add to an excess of aqueous Sodium Metabisulfite solution. Decant liquid to the drain. Treat the solid as normal refuse. Always comply with local, state, and federal regulations.

SECTION 7: Handling and Storage

7.1. Precautions for Safe Handling and Storage Conditions

Store locked up. As with all chemicals, wash hands thoroughly after handling. Avoid contact with eyes and skin. Protect from freezing and physical damage. Keep away from combustibles, ignition sources, organic materials, or other oxidizable substances. Refrigeration will slow down decomposition. Containers should be vented. Periodically check for bulging containers, which can burst from increased pressure. Do not return any unused material to the original container. Utensils used must be of compatible materials like glass, stainless steel, aluminum or plastic.

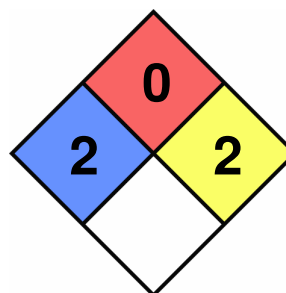
