SECTION 4: First-Aid Measures

4.1. Description of Necessary Measures

4.2. Most Important Symptoms and Effects, Acute and Delayed

Harmful if inhaled Mildly corrosive liquid. May irritate eyes and skin. Wash areas of contact with plenty of water for at least 15 minutes. If ingested, dilute with large quantity of water. Do not induce vomiting. Call a physician. EYE CONTACT: May cause irritation, redness, pain, and tearing. SKIN CONTACT: May cause irritation, redness, and pain.

4.3. Immediate Medical Attention or Special Treatment Needed

Cover the spill with Sodium Carbonate or a soda ash-slaked lime mixture (50:50). Mix and add water to form slurry. Decant the liquid to the drain with excess water. Treat the solid residue as normal refuse unless there are regulations prohibiting this practice due to the iron content. Always dispose of in accordance with local regulations.

Store locked up. As with all chemicals, wash hands thoroughly after handling. Avoid contact with eyes and skin. Protect from freezing and physical damage. Do not mix with bases. Contact with water will generate heat.

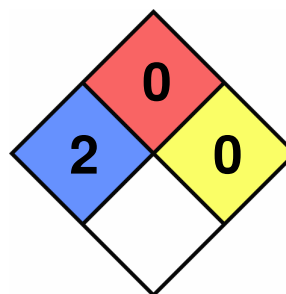
