4.1. Description of Necessary Measures

Causes severe skin burns and eye damage WARNING! Mildly corrosive. May be harmful if swallowed. Avoid ingestion or contact with eyes, skin, or clothing. If swallowed, do not induce vomiting. Give large quantity of water and call a physician. Wash areas of contact with plenty of water for 15 minutes. For eyes, get medical attention. EYE CONTACT: May cause irritation, redness, pain, and tearing. SKIN CONTACT: May cause irritation, redness, and pain. CHRONIC EFFECTS / CARCINOGENICITY: Chronic respiratory disease and dermatitis may develop from repeated exposures.
