SECTION 4: First-Aid Measures

4.1. Description of Necessary Measures

4.2. Most Important Symptoms and Effects, Acute and Delayed

If ingested, dilute with water and call a physician. Do not induce vomiting. Wash areas of contact with plenty of water for 15 minutes. For eyes, get medical attention EYE CONTACT: May cause irritation and burns. SKIN CONTACT: May cause irritation and burns. 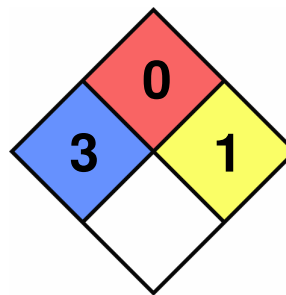
