SECTION 4: First-Aid Measures

4.1. Description of Necessary Measures

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Corrosive! Causes irritation and burns. Can cause burns that may lead to permanent impairment of vision, including blindness.

Ingestion: IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Do not induce vomiting. Give large quantity of water. Call a physician immediately.

Inhalation: IF INHALED: Remove person to fresh air and keep comfortable for breathing.

Skin Contact: IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower. Causes severe burns.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage CAUTION! Corrosive. Causes severe burns. May be fatal if swallowed. Harmful if inhaled. Wash areas of contact with water for at least 15 minutes. Call a physician if irritation develops. If ingested, dilute with water and call a physician. Do not induce vomiting. For eyes, flush out with plenty of water for at least 15 minutes. Call a physician. Reacts violently with acids. EYE CONTACT: Corrosive! Causes irritation and burns. Can cause burns that may lead to permanent impairment of vision, including blindness. SKIN CONTACT: Causes severe burns. CHRONIC EFFECTS / CARCINOGENICITY: Repeated exposures to Sodium Hydroxide solutions has a destructive effect on tissue.

4.3. Immediate Medical Attention or Special Treatment Needed

Immediately call a poison center or doctor. Irrigate immediately with large quantity of water for at least 15 minutes. Call a physician if irritation develops. Remove to fresh air. Give artificial respiration if necessary. If breathing is difficult, give oxygen. Flush with plenty of water for at least 15 minutes. Call a physician if irritation develops. Do not induce vomiting. Give large quantity of water. Call a physician immediately.

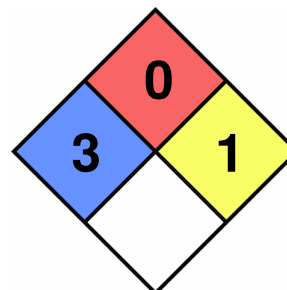
