SECTION 4: First-Aid Measures

4.1. Description of Necessary Measures

4.2. Most Important Symptoms and Effects, Acute and Delayed

Toxic if inhaled DANGER! Causes severe burns. May be fatal if swallowed. Do not get in eyes, on skin, or on clothing. If swallowed, do not induce vomiting. Give large quantity of water. 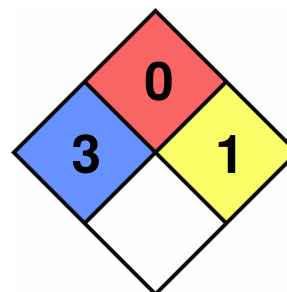
