SECTION 4: First-Aid Measures

4.1. Description of Necessary Measures

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Causes severe irritation, redness, pain, tearing and burns.

Ingestion: IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Do not induce vomiting. Give large quantity of water. Call a physician immediately.

Inhalation: IF INHALED: Remove person to fresh air and keep comfortable for breathing.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Harmful if inhaled DANGER! Causes burns. May be harmful if swallowed. Avoid ingestion or contact with eyes, skin, or clothing. If swallowed, do not induce vomiting. Give large quantity of water and call a physician. Wash areas of contact with plenty of water for 15 minutes. For eyes, get medical attention. EYE CONTACT: Causes severe irritation, redness, pain, tearing and burns. SKIN CONTACT: May cause irritation, redness, and pain. CHRONIC EFFECTS / CARCINOGENICITY: Chronic respiratory disease and dermatitis may develop from repeated exposures.

4.3. Immediate Medical Attention or Special Treatment Needed

Immediately call a poison center or doctor. Irrigate immediately with large quantity of water for at least 15 minutes. Call a physician if irritation develops. Remove to fresh air. Give artificial respiration if necessary. If breathing is difficult, give oxygen. Flush with plenty of water for at least 15 minutes. Call a physician if irritation develops. Do not induce vomiting. 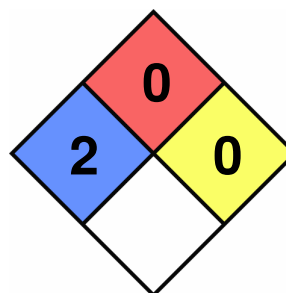
