SECTION 4: First-Aid Measures

4.1. Description of Necessary Measures

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. May cause irritation, redness, pain, and tearing.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage Mildly corrosive liquid. Avoid contact with skin, eyes, and clothing. May cause mild irritation. If swallowed, do not induce vomiting. Dilute with water and call a physician. Wash areas of contact with plenty of water. EYE CONTACT: May cause irritation, redness, pain, and tearing. SKIN CONTACT: May cause irritation and temporary discoloration of skin.
